MID-TERM NEEDS| NOTEWORTHY ITEMS

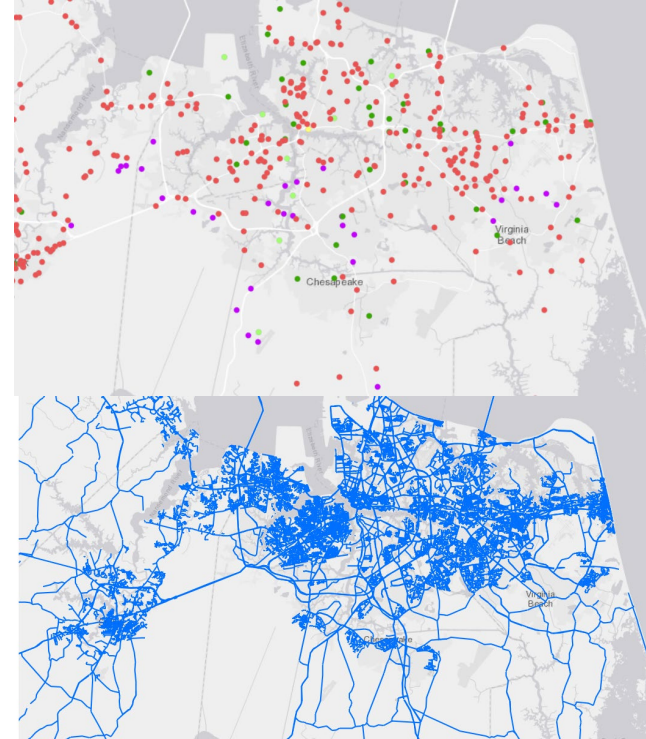
1. CTB approves Methodology and accepts 2019 VTrans Mid-Term Needs
 - Through data-driven Needs assessment over 80 million data points were processed
 - If a data point is found to be inconsistent with the Commonwealth Transportation Board (CTB) approved 2019 Mid-term Needs Identification Methodology, the approved methodology takes precedent.



MID-TERM NEEDS| NOTEWORTHY ITEMS

2. Method of Analysis and Presentation

- Needs are more specific and assigned to:
 - **Nodes:** Intersections, Rail Stations, Activity Center Centroid, Industrial and Economic Development Area.
 - **Segments:** Congestion, Reliability, Transit Access, Non-motorized Access, etc.



MID-TERM NEEDS | NOTEWORTHY ITEMS

3. Consider taking a comprehensive view of the Mid-term Needs

- There is one document per Construction District for Mid-term Needs. It includes Needs for CoSS, RN, UDA, and Safety
- Mid-term Needs can be **viewed across travel markets and need types**.
 - Example: Identify segments that have both, Need for Safety Improvement **AND** Need for Bicycle Access
 - Example: Identify segments that have both, Need for Transit Accessibility Improvement for Equity Emphasis Areas **AND** Need for Sidewalks

MID-TERM NEEDS| NOTEWORTHY ITEMS

4. Needs are not solutions

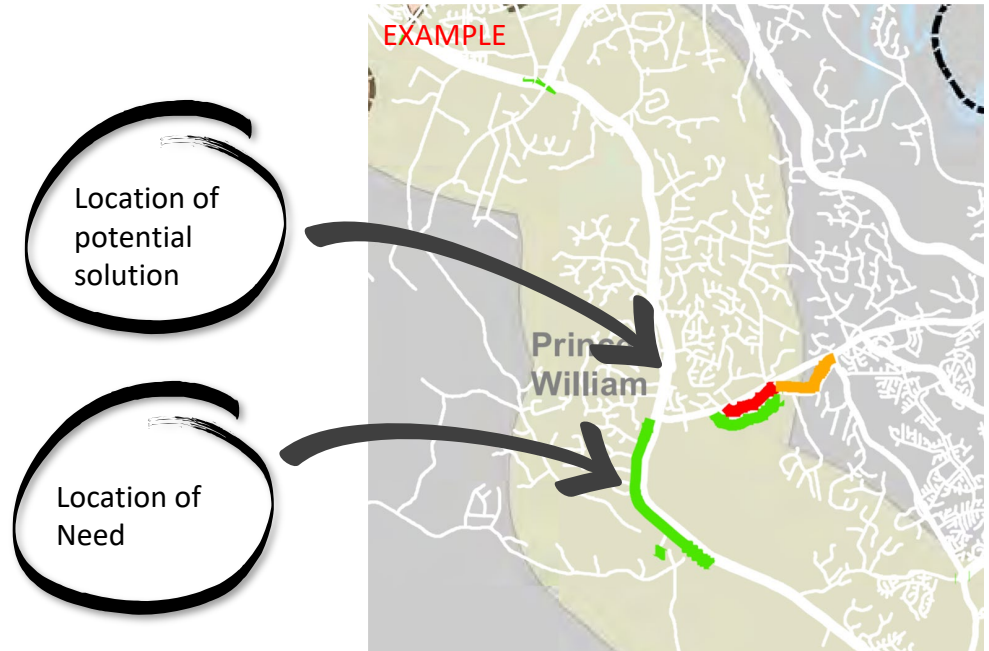
- A highway Congestion or Reliability Need may also be addressed by rail or transit

MID-TERM NEEDS | NOTEWORTHY ITEMS

5. Location of a Need may not necessarily be same as the location of the solution
 - A solution to a Need may be elsewhere on the same facility or on a parallel facility

Needs layers & conversion for Smart Portal

Conversion to VTrans Needs for Portal.gdb

- CoSS Needs Points - includes Rail, Safety (“Yes (Coss)”)
- CoSS Needs Segments - includes Congestion, Reliability, Capacity Preservation, TDM, Safety (“Yes (CoSS)”)

- RN Needs Points - includes IEDA (Yes “UDA, RN”)), Transit Access
- RN Needs Segments - includes Congestion, Reliability, Capacity Preservation, TDM, Transit Equity, Bicycle Access, Pedestrian Access, and UDA (“Yes (UDA, RN)”)

- UDA Needs Points - includes IEDA (UDA only)
- UDA Needs Segments - includes UDA (“Yes (UDA only)”)

- Safety Needs Points - includes Safety (Yes)
- Safety Needs Segments - includes Safety (Yes), and Pedestrian Safety
